

### AB1886 - WHY SHOULD YOU CARE?

AB1886 sets minimal and flexible standards for members of our profession. AB1886 does not change the requirements for facilitators monitored by the Los Angeles County Probation Department's Monitoring Team.

The original template for AB1886 is Draft 14, enforced by Jim Wright's Monitoring Team and developed by a coalition of shelter advocates, the Los Angeles County Domestic Violence Council, the Probation Department, and batterers' group facilitators.
